

DECLARATION

of compliance with the requirements set out in Article 5(4) and (5) of Regulation (EU) 2025/40 (PPWR)

Based on the relevant raw-material supplier documentation we hereby declare that:

1. Heavy Metals

In accordance with **Article 5(4) of Regulation (EU) 2025/40**, the sum of the concentration levels of lead (Pb), cadmium (Cd), mercury (Hg) and hexavalent chromium (Cr(VI)) present in packaging or packaging components shall not exceed 100 mg/kg.

Based on the relevant raw-material supplier documentation, the total incidental concentration of cadmium, chromium, lead and mercury in the polypropylene raw materials covered by this statement is below 100 mg/kg (100 ppm).

These heavy metals are not intentionally incorporated into the relevant polypropylene raw materials during production.

2. PFAS

Based on the relevant raw-material supplier documentation, poly- and perfluoroalkyl substances (PFAS) are not intentionally incorporated into the polypropylene raw materials covered by this statement and are therefore not expected to be present in the material.

The relevant supplier documentation covers, among others, PFAS, PFOS, PFOA, perfluorinated carboxylic acids (PFCAs), perfluorochemicals (PFCs), perfluoro-alkyl phosphate esters (PAPs), fluorotelomers and other fluorinated substances.

Manufacturer does not intentionally add PFAS-containing additives, processing aids, surface treatments, coatings or barrier layers during the manufacture of the polypropylene packaging covered by this statement.

The relevant raw-material supplier documentation states that the material has not been specifically tested for the presence of the substances covered by this declaration.

Based on the above, we declare that the product(s) covered by this declaration complies with the requirements set out in **Article 5(4) and (5) of Regulation (EU) 2025/40** of the European Parliament and of the Council (Packaging and Packaging Waste Regulation – PPWR).
