

DECLARATION OF CONFORMITY

HEAVY METAL CONTENT

The total concentration of lead (Pb), cadmium (Cd), mercury (Hg) and hexavalent chromium (Cr VI) in the packaging does not exceed the limit values set out in applicable European legislation.

HIGHLIGHTED HAZARDOUS SUBSTANCES

The manufacturer declares that, based on the information available to it:

- the product does not contain intentionally added PFAS compounds;
- the product does not contain substances of very high concern (SVHC) in concentrations prohibited by law;
- the raw material used complies with the REACH regulation.

BISPHENOL A (BPA)

If the product is intended to come into contact with food, the raw material used complies with the relevant European regulations, including the requirements for bisphenol A.

The liner is suitable for recycling in the PE plastic waste stream, if a suitable selective collection and recycling infrastructure is available.

Material designation: LDPE 04

During the design of the product, we have strived to use the least possible amount of material, taking into account the necessary technical requirements.

The wall thickness, mass and geometric design are determined by the functional requirements.
