PRESENCE OF SUBSTANCES SUBJECT TO RESTRICTIONS

Based on the information and declarations received from raw material suppliers, the materials used for the manufacture of our products do not intentionally contain heavy metals (lead, cadmium, mercury and hexavalent chromium) in quantities exceeding the limits set by **Directive 94/62/EC** and subsequent amendments.

We also declare that, according to the information provided by our suppliers, the raw materials used do not contain substances belonging to the PFAS family (per- and polyfluoroalkyl substances) as defined and regulated by Article 5 of **Regulation (EU) 2025/40**.

We confirm that manufacturer do not intentionally add heavy metals or PFAS substances during any stage of our production process.

This declaration is based exclusively on the information and declarations provided by our suppliers and on our knowledge of the company's production processes.
