When used as specified below, the overall migration as well as the specific migration do not exceed the legal limits.

Overall and specific migration limits will not be exceeded and are in accordance with Commission Regulation (EU) 10/2011 with food simulants 3% acetic acid and 10% ethanol.

Specification of the intended use or limitations:

Type(s) of food intended to come into contact with the products:

All types of food.

Limitation:

Storage time up to 30 days at a temperature up to 40 °C, 2 hours at a temperature of 70 °C and 15 minutes at a temperature of 100 °C.

Not suitable for use in traditional or microwave ovens.

This declaration is valid for the products we delivered and its use as specified above. The verification of compliance was performed based on the above rules; according to which the product complies with the legal requirements subject to adherence to the stated conditions for contact with food. In case of deviations from the intended use, the user is responsible for verifying compliance and suitability. In particular it is emphasized that in case of printed material, no contact is allowed between the printing ink and the food product.
