Type(s) of food intended to come into contact with the products: All types of food.



## Limitation:

Temperature range of use is -25 °C - 60 °C

## Contact conditions:

Any long term storage at room temperature or below, including heating up to 70 °C for up to 2 hours, or heating up to 100 °C for up to 15 minutes.

Ratio of food contact surface area to volume used to determine the compliance of the material or article: 6 dm²/1 kg

This declaration is valid for the products we delivered and its use as specified above. The verification of compliance was performed based on the above rules; according to which the product complies with the legal requirements subject to adherence to the stated conditions for contact with food. In case of deviations from the intended use, the user is responsible for verifying compliance and suitability. In particular it is emphasized that in case of printed material, no contact is allowed between the printing ink and the food product.
