Specification of the intended use or limitations:

Types of food that may come into contact with the material:

Aqueous, acidic, fatty and alcoholic foodstuff.

Usage:

Use includes heating to 70°C for up to 2 hours or 100°C for 15 minutes, not followed by long-term storage at room temperature or in a refrigerator.

Migration limits are not exceeded under following conditions:

Aqueous + acidic	3% acetic acid	2 h at 70 ± 2 °C
Alcoholic + aqueous	10% ethanol	2 h at 70 ± 2 °C

Organoleptic testing showed no distinct change of smell and taste under following test conditions:

Aqueous	Baby water	2 h at room temperature (filled at 70 °C)

Ratio of food contact surface area to volume used to determine the compliance of the material or article: 108 cm²/120 ml..

This declaration is valid for the products we delivered and its use as specified above. The verification of compliance was performed based on the above rules; according to which the product complies with the legal requirements subject to adherence to the stated conditions for contact with food.
